LOCATION:

The event will be held in and about the Oceanside Civic Center.

DATE & TIME:

Saturday and Sunday, April 17 & 18, 2010 from 10:00am to 5:00pm

ART CATEGORIES:

Oils, acrylics, watercolors, pastels, drawing, print-making, sculpture, ceramics, photography, glass and mixed media.

NO craft or bazaar-type items and no clothing.

FEES FOR ART DISPLAY:

A. Returning artists from ODA 2009

Received by February 20th

10'x10' space = \$60 or 10'x20' space = \$120

B. Other artists

Received by February 20th

10'x10' space = \$70 or 10'x20' space = \$140

C. Late application

Received between February 21st & March 13th

10'x10' space = \$90 or 10'x20' space = \$180

Artists must supply their own display table, chairs and canopy. Art must be displayed both Saturday and Sunday. Artists are encouraged to demonstrate in their space.

PERFORMANCE CATAGORIES:

Concert band, symphonic orchestra, solo and small ensemble (vocal and instruments), choral ensemble, dance and theater (short plays, mime readings).

ELIGIBILITY:

Open to artists either as individuals or as members of performing groups. Open to amateurs and professionals. Open to elementary through high school students involved in school-sponsored art programs only.

SALES:

Please consider a voluntary commission of 10% on your total sales – as a fully tax-deductible donation to Oceanside Cultural Arts Foundation – tax ID#33-0357137. Each artist is responsible for their own sales and appropriate taxes.

VISUAL ARTISTS

- Four color photos representative of the work to be shown. Label each with name, phone number and media.
- Photo of display - indicate size and type of cover on form.
- Payment – Check or money order payable to OCAF (see deadlines and fee schedules)
- Self-addressed, stamped envelope for the return of materials.
- An application is required from each artist displaying. Only one person may sell and show their work in each space.

PERFORMING ARTISTS

- Audition video tape, representative of the artists who will be performing.
- Self-addressed, stamped envelope for the return of video.
